- Applications without Resume/CV, self-attested copies of certificates (Qualification & Experience) and subject matter will not be considered.
- Educational qualifications should be from a University/Institution/Board recognized by Govt. of India/approved by Govt. Regulatory Bodies.
- If the applicant possesses an equivalent qualification, he/she should also attach the equivalency certificate along with the qualification certificate or else the application will not be considered.
- Applicants need to attach a valid certificate for every experience he/she mentioned. In the case of the latest/current experience an affidavit bearing all details (name of organization, designation, period, task and duties) shall be attached. The copy of appointment letters, salary certificates, pays slips etc. will not be accepted in lieu of work experience certificate.
- Only Post qualification experience as on 01.12.2021 will be considered.
- Have a valid personal e-mail ID and mobile no., which should be kept active till the completion of this Recruitment Process. All official communication will be sent to the registered e-mail id of the candidate.
