- **Candidate should clearly mention their “Date of Birth” & “Percentage/Class” secured in the qualifying examination in their CV.** The conversion of grade/CGPA to percentage would be based on the procedure certified by the University from where they have obtained the degree. The onus of proving the conversion from grade/CGPA to percentage of marks would rest with the candidate.
