- 2. Work related to Infrastructure (Cloud and Hosting / Server / Database / Institute IT Services)
  - a. Setting up and maintenance of campus cloud infrastructure
  - b. Management of thousands of campus email accounts (Creation, maintenance and deletion in time);
  - c. Support for a wide range of maintenance activities related to campus network, ranging from installing operating systems to debugging connectivity issues;
  - d. Preparing proposals for purchase of softwares such as Endpoint security software (e.g., anti-virus software), Office softwares;

- b) Experience with any of the SIEM (QRadar, Splunk, Nitro, etc.), SOAR (Resilient, Demisto, ServiceNOW, etc.), Ticketing (JIRA, ServiceNow, Remedy, etc.)
