विषय/Sub:- Filling up the post of Harbour Master in Cochin Port on absorption through composite method - reg.

1. Applications are invited for filling up of 1 (one) post of Harbour Master in the scale of pay of Rs.90,000 - 2,40,000 (Pre-revised Rs.36,600-62,000) in Cochin Port Authority by absorption through composite method.

2. As per Recruitment Rules, for absorption through composite method, Officers holding analogous posts or Pilots in scale of pay 70,000-2,00,000 (Pre-revised Rs.14,500-18,700) and above with 5 years regular service in the grade in a Major Port are eligible. Recruitment Rules is attached as **Annexure -I.**

3. The requisite educational & other qualification prescribed as per Recruitment Rule , are:

(a) Must hold a Certificate of competency as Master of foreign going ship issued by the Ministry of shipping, Govt. of India or an equivalent qualification recognized by the Ministry of Shipping, Govt. of India.

(b). Must hold Pilot license and have 6 years experience either as Master of Foreign going ship or in Piloting or cumulative.

4. The selection is by merit for which the benchmark in overall grading in the ACRs will not be below "Very Good".

5. Applications in the prescribed format **(Annexure-II)** from eligible and willing officers, who satisfy the provisions of Recruitment Rules for the post of Harbour Master, may be forwarded through proper channel along with the following documents so as to reach this office on or before **01.08.2022**, which shall be the crucial date for determining the qualification and experience.

- a. Attested copies of ACRs/APARs of the applicant for the last 5 years.
- b. Attested copies of certificates of academic qualification to prove eligibility.
- c. No-Objection Certificate of the respective Ports
- d. Certificate by Head of Office of the applicant as per the format.
- e. An undertaking of the applicant not to withdraw his candidature, if selected.

The candidate who withdraws his candidature for the post after his selection by the SSC, will be liable for debarment from future selection to Dy.HoD level posts in all Major Port Trusts for a period of two years, as per the instructions issued by the MoPS&W vide A-29018/4/2018-PE-I dated 11.08.2021.

7. The applications received through proper channel only will be entertained. The applications received after the last date or without ACRs/APARs and other requisite documents or otherwise incomplete will not be considered. In case of receipt of advance copy of application in respect of any applicant by this Port, candidature of the applicant will not be considered, if the application is not received through proper channel within 15 days of the last date of receipt of applications.
