Eligible candidates are invited to attend a walk-in-Interview with all relevant documents for the temporary post of Young Professional-I (01 No.) (on contractual basis) to work under INFAAR project at **MFB Division** of CIFT, Cochin. The duration of the contract is upto **March, 2023 or until order from Network coordinator.**

I. Young Professional-I :

Emoluments	: Rs.25,000/- per month (Consolidated)
Essential Qualification	: First class Master's degree in the field of Microbiology/ Biotechnology/ Aquatic Animal Health Management/ Fishery Microbiology/ Fish Pathology/ or any life sciences with experience in the field of testing.
Desirable	: CSIR/ UGC/ ICAR Net qualified. Experience on Antimicrobial resistance and handling of bacteria and molecular techniques. Excellent computer documentation and analytical skills. Prior experience in handling microbial cultures and molecular techniques.
Nature of work	: Place of posting will be at CIFT, Cochin. Work involves extensive field trips, liaison with stakeholders, testing of aquaculture samples for antimicrobial resistance, database development and laboratory analysis.
Age limit	: Candidates should be above 21 years and maximum of 45 years as on date of interview. Age relaxation as per rules.

Terms & Conditions:

1. Registration will begin at 9.00 a.m. and will close at 10.00 a.m.
2. Age relaxation of 3 years for OBC candidates and 5 years for SC/ST candidates is permissible.
3. Candidate should possess 1st class or 60% marks or equivalent overall GPA
4. Candidates are required to submit detailed bio-data (in the enclosed format) affixing a recent passport size photograph alongwith attested copies of all the Certificates in support of their claims regarding age, educational qualifications, experience, Scheduled Caste/ Scheduled Tribe/OBC etc. **The original certificates shall be produced for verification before the interview.**
5. **The candidate should at least hold a Provisional Certificate in r/o. Graduation/ Professional Courses. (website results/ result awaiting candidates will not be considered)**
6. The selected candidate will be recruited on contract basis under ICAR norms. The post is purely temporary.
7. The candidate attending the interview should ensure that they fulfill all the eligibility conditions. No correspondence will be entertained from the candidates for selection/test/appointment.
8. Candidates already employed should submit "No Objection Certificate" from the present employer while attending the interview.
