Job Title: Veterinary care coordinator Department: General Administration-Estate

Part A: Job Specification

Job Purpose

• To maintain a focal point for institutional animal care Programs and response team for animal incidents, including encroachment of human living spaces by wild animals.

Reporting and Relationships

• To Report to Estate Supervisor and General Administration i/c.

Job Context & Major Challenge(s)

• IIMK Estate is spread over 100 acres, mostly forest areas and habitat for many animals including wild animals. Estate is having porous boundary for stray animals to walk in and upto to IIMK Residential areas and Hostels in search of food waste etc and especially during night time.

• Currently there are incomplete records/estimate of the animal population inside the campus, even for stray dogs, cats and other pets inside houses as well.

• There are more than 200 residents within campus besides 900+ students, many of them being animal/pet friendly; and have habit of feeding them occasionally.

• Due to varying seasonal changes and food waste animals are prone to carry communicable diseases contagious to kids etc and uninformed resident population with low awareness.

• Stray animals have often attacked people who go for walking or children playing increasing fear amongst such residents and resultant ill treatment of animals.

• Security and Housekeeping as well as Estate Offices are also involved in maintaining an animal friendly environment within IIMK Campus.
