Interested and qualified candidates may report for the Walk in Interview with Bio-data, Original and Copies of certificates to prove their age, qualification, experience etc. Details are as follows

- No of vacancies** : Existing and Arising Vacancies
- Tenure of Appointment** : Maximum up to 3 years subject to the performance.
- Mode of selection** : Written test / Interview
- Nature of appointment** : Temporary (purely on contract)
- Venue** : Administrative Block, MCC
- Application Fee** : **Rs.100/- ( for all candidates)**
- Selected candidate will be Posted at Malabar Cancer Centre on contract basis
- Candidates will mark their attendance between **10.00 AM to 11.00 AM 12-05-2023** by paying **Rs.100/-** as application fees. Late comers will not be entertained.
- Candidates without **copies of certificates showing age, qualification and experience** will not be considered eligible for further recruitment procedures.
- Selection will be based on qualification and experience and performance in the interview. Claims in respect of Qualifications, Experience, etc. should be supported by Self Attested copies of relevant documents; Candidates **should produce the originals at the time of interview.**
- If the numbers of applications are high then a written/online test will be conducted.

12. No TA/ DA will be paid for the Interview/ Written test.
13. Canvassing in any form will lead to automatic disqualification. Candidates are advised to desist from such unholy practices
14. Age will be calculated as on 1<sup>st</sup> January of the year. ie. **01-01-2023**.
15. The Experience will be calculated from the date on which requisite qualification is obtained to date of notification.
