1. **No of vacancies** : Existing and Arising Vacancies

2. **Tenure of Appointment** : Maximum up to 3 years subject to the performance.

3. **Mode of selection** : Written test / Interview

4. **Nature of appointment** : Temporary (purely on contract)

5. **Venue** : Administrative Block, MCC

6. Application Fee : Rs.100/- (for all candidates)

- 7. Selected candidate will Posted at Malabar Cancer Centre on contract basis
- 8. Candidates will mark their attendance between **10.00 AM to 11.00 AM 12-05-2023** by paying **Rs.100**/- as application fees. Late comers will not be entertained.
- 9. Candidates without **copies of certificates showing age, qualification and experience** will not be considered eligible for further recruitment procedures.
- 10. Selection will be based on qualification and experience and performance in the interview. Claims in respect of Qualifications, Experience, etc. should be supported by Self Attested copies of relevant documents; Candidates should produce the originals at the time of interview.
- 11. If the numbers of applications are high then a written/online test will be conducted.

- 12. No TA/ DA will be paid for the Interview/ Written test.
- 13. Canvassing in any form will lead to automatic disqualification. Candidates are advised to desist from such unholy practices
- 14. Age will be calculated as on 1stJanuary of the year.ie.**01-01-2023.**
- 15. The Experience will be calculated from the date on which requisite qualification is obtained to date of notification.
