2. Age relaxation will be applicable as per rules. Applications should be submitted as per the proforma given below along with recent passport size photo, attested copies of the documents to prove date of birth, caste, qualification, experience etc. Candidates should submit attested copy of caste certificate from the Competent Authority. Those who are presently employed should apply through proper channel.

3. Employees of the Board of any Major Port possessing the prescribed qualification and experience may also apply : Provided that the age limit in such case shall not exceed 55 (Fifty five) years.

4. The five posts of Pilots will be filled up in two phases as below.

a) Two posts : 1 OBC and 1 ST posts will be filled up immediately and balance

b) Three posts : 1 posts of SC and 2 posts of UR will be filled up subsequently on receiving the approval of competent authority which is under process.

5. Candidates will be considered for written test and / or interview subject to fulfillment of the above qualification and experience. Cochin Port reserves the right to shortlist the applicants based on merit.

6. The applications should reach the Secretary, Cochin Port Authority, Willingdon Island, Cochin, Kerala, 682009, on or before 25.03.2024, which shall be the crucial date for determining, the qualification, experience and age. The applications received after the last date or otherwise incomplete will not be considered.
