- Applications are invited for filling up one post of Dy. Chief Mechanical Engineer (Ele/E&C)in the Scale of Pay of Rs.80000-220000 (Pre-revised Rs.16000-20800) in Cochin Port Authority by absorption through composite method.

As per Recruitment Rules, for absorption through composite method, Officers holding analogous posts or the post of Superintending Engineer and equivalent posts in the Electrical/Electronics & Communication discipline of M&E Engg. Dept. in the scale of pay of Rs. 60000-180000 (pre-revised Rs. 13000-18250) with 3 years regular service in the grade in the respective discipline in a Major Port or Superintending Engineer and equivalent post in the Electrical/Electronics & Communication discipline of M&E Engg. Deptt. with 2 years regular service in the grade and a combined regular service of 7 years in the scales of pay of Rs. 50000 - 160000 (Pre-revised Rs. 10750-16750) and Rs. 60000-180000 (pre-revised Rs. 13000-18250) in the respective discipline in a Major Port will be eligible.
